**Renovations / modifications at the Consular section premises of Embassy of India in Amman(Jordan)**

1. The Embassy of India in Amman (Jordan) invites sealed bids from the reputed companies / contractors for the following renovations/modifications at the premises of its Chancery:

(A) **Work No.I:** Building of a steel-framed canopy at the Consular section of the building

(i) An all-weather steel-framed canopy with durable roof clay tiles is to be built at the consular wing of the building. The dimension of the area where canopy is proposed is about 18 x 6 mtrs and should have proper electrical fittings/light features and roof drainage system.

(B) **Work No.II:** Building of toilets (two rest rooms) to serve consular visitors

(i) Construction of external two separate rest-rooms (for Gents & Ladies), including required walls, cement ceiling and roof top, doors, locks, water tank, water pipes, water pump, water heater, aluminium and glass windows, floor tiling, electrical wiring(plugs and sockets), internal sanitary, connection with drainage source, toilet accessories sets and ventilation fans. Walling up the windows of Attache(Cons.) office.

2. The scope of work, related to above-mentioned four works, include building / construction work, cement & masonry work, electrical fittings/accessories, plumbing including installation of WC/Wash-basins/water tank (in two rest rooms), exhaust / ventilation system, floor & wall tiling work, painting and any other work necessary for the completion of the above-mentioned work. Keeping in view the layout of the building, companies are advised to propose design, model, material/make etc., along with bids, for final selection by the Embassy of India, Amman(Jordan).

3. Participating companies are requested to bid for each work individually in sealed envelope & forward the same in one single sealed envelope to Embassy of India, Amman.

4. The work must be completed as per following time-line upon awarding and confirmation of order and should include complete cleaning of the area and removal of debris:

(i)	Work I	:	15 days
(ii)	Work II	:	40 days

5. Companies are welcome to inspect the scope of work by prior appointment with the Embassy of India, Amman.

6. Interested parties may forward their sealed quotations to the Head of Chancery, Embassy of India, Amman (Jordan) at No.24, Al-Hidhab Street, Abdoun, Amman with

superscription "Renovation / modifications at Embassy of India, Amman". The companies may also send their profile, workmanship certificates, and previous work, if available, along with the bids.
